NH ED Subject Area Test Requirements & Instructions

For NH Licensure, most areas require <u>Praxis II</u> (per Ed 500 Administrative Rule (currently Ed 505.01/Ed 514.01 formerly)) as well as <u>Foundations of Reading</u> for Elementary Education). Praxis II is not required for graduation or for recommendation for licensure. However, it is strongly recommended that teacher candidates complete the tests required for licensure in their area as soon as possible, preferably *before* the internship begins, while coursework is still fresh and to make licensure as efficient as possible after graduation.

You can also submit out of state/national testing reports for evaluation as a comparable test.

Elementary Education K-8 Only:

Elementary Education K-8 requires (in addition to the requirements for Elementary
Education K-6) a 15 credit concentration on your transcript in one of the following areas:
English, Math, Science, or Social Studies. You must also submit passing scores on the

reports for evaluation as a comparable test.

How do I submit documentation or see if documentation has been received?

NH required Praxis/ETS or Pearson tests recently taken in NH are provided to the NHED electronically by the testing company. It can take up to 6-8 weeks for the NHED to receive passing scores electronically from testing companies and for the scores to be visible in your EIS account.
